

NOTE:

1. Validity of the short list will be for **one year** from the date of publication of the result and renewable accordingly.
2. Qualification and experience should be in relevant discipline/field and from an institute of repute. Experience should have been gained after acquiring the minimum essential qualification.
3. Qualification, experience, other terms and conditions may be relaxed/ altered at the discretion of the Project Investigator.
4. Upper age limit may be relaxed as per Govt. of India rules.
5. The posts are purely on contract basis for an external sponsored project, and no claim for any other regular post in AIIMS Nagpur shall be entertained.
6. Selected candidate may have to carry out visits to Urban and Rural health centres of the Department of Community Medicine, AIIMS Nagpur
7. **Valid email id and mobile number is compulsory.**
8. Consolidated salary of the post may vary from time to time. No other allowance/ facilities other than consolidated salary shall be extended.
9. Decision of the Principal Investigator will be final.
10. No TA/ DA will be paid for the interview.
