Recruitment to the Posts under ICMR Research Project 'AI-Powered tool for autonomous identification of retinal phenotypes as potential diagnostic biomarkers for Schizophrenia spectrum disorders'

A call for the **02 posts** in the research project titled, "AI-Powered tool for autonomous identification of retinal phenotypes as potential diagnostic biomarkers for Schizophrenia spectrum disorders" funded by Indian Council of Medical Research (ICMR) under Principal Investigator, Dr Sonakshi Jyrwa, Associate Professor, Psychiatry.

The duration of the project is 36 months. The tenure for the post at first appointment would be for 11 months, extendable up to the duration of the project based on performance and availability of the funds under this research project.

Application and Selection Procedure

1. The candidate must apply with duly filled applications in prescribed format as given in the google form link with the necessary qualifying certificates and proof for previous work experience attached.
2. The application should be filled in online google form link- <https://forms.gle/h7fvQhmeRZo5qNGEA>
3. No application form will be accepted through email/post.
4. The scanned copies of the certificates including proof of date of birth, educational qualification work/ clinical/research experience should be uploaded on the google form link given above.
5. The curriculum vitae of the candidate needs to be filled in the format given as **Annexure I** and uploaded in the google form.
6. The mode of selection will be through **personal interview** at AIIMS Nagpur.
7. The applicants may be shortlisted based on the educational qualifications/experience etc., The notice for interview along with the list of eligible, shortlisted candidates will be published on AIIMS Nagpur website. A call for interview will be sent to the shortlisted candidates through email.
8. In case of more than 15:1 application per post; written test will be conducted to shortlist the candidates for the personal interview.

Terms & conditions:

1. All advertised posts are tenure jobs for fixed duration under ICMR funded projects.
2. These are not the regular posts under ICMR or AIIMS Nagpur.
3. Based on this experience, the selected candidate cannot claim any permanent employment either from ICMR or from AIIMS Nagpur.
4. The appointment will be purely on a temporary basis. Duration of first appointment will be for **11 months**. The contract will be renewed based on the performance evaluation by the project investigator with the approval of the Director.
5. In case the candidate wishes to resign from the post, he/she should furnish a notice of 15 days period.
6. Once the project duration is completed the tenure is automatically over for all the candidates selected for this project.
7. The candidate should be able to speak fluently in English, Marathi and Hindi.
8. The appointee agrees to fulfil the norms for output in terms of quality and quantity of the work assigned to him/her and if the appointee engaged is not able to fulfill the prescribed norms, his/her services will be terminated with notice period of 7 days.
9. The principal investigator reserves the right to terminate the contract with one month notice period.
10. No TA/DA will be provided for attending the interview.
11. Apart from the consolidated mentioned salary per month including HRA, the candidate is not admissible for any other allowances.
