ELIGIBILITY STATUS OF CANDIDATES AFTER COMPLETION OF DOCUMENT VERIFICATION FOR THE POST OF NURSING OFFICER THROUGH NORCET-06 AT AIIMS NAGPUR

In reference to notice No. 28/2024 date: 26.02.2024 Of AIIMS New Delhi regarding Nursing Officer Recruitment Common Eligibility Test (NORCET)-06 inviting application for posts of Nursing Officer (Staff Nurse Grade II) on Direct Recruitment Basis on behalf of AIIMS Nagpur and Notification No. 34/2024, 39/2024 & 53/2024 dated: 19th April 2024, 08th May 2024 & 06th June 2024 respectively regarding result and announcement of Online Seat Allocation for candidates allotted AIIMS Nagpur.

2. In this connection, AIIMS Nagpur issued Notice No: AIIMS/NGP/NORCET/2024/1014 Dated: 21.06.2024, regarding verification of eligibility criteria & Original document of NORCET-06 qualified candidates for post of Nursing Officer on direct recruitment basis at AIIMS Nagpur. The provisionally eligible candidates were called for document verification at AIIMS Nagpur on 01st July 2024.

3. On the basis of documents submitted by the candidates in support of their eligibility and after examination of the documents, eligibility status of candidates has been prepared and placed as **ANNEXURE-A**.

4. All the 'Provisionally eligible' candidates are mandatorily required to submit documents as a mentioned against their name in support of their eligibility by email to nonfac.recruitment@aiimsnagpur.edu.in latest by 26.07.2024 They should email all these documents in a single (merged) pdf file.

5. In case no representation is received from 'Provisionally eligible' candidates within the specified date (26.07.2024) then it will be considered as the concerned candidate is not having any documents/claim in support of his/her eligibility. Such candidates shall be declared 'Not Eligible' for NORCET-06 without giving any further notice.

6. Representation received after 26.07.2024, through email or any other mode from any of the candidates will not be considered under any circumstances.

7. Offer of appointment to all 'Eligible' candidates, mentioned in the ANNEXURE-A of this notice will be issued shortly.

8. Candidates must note that their candidature is purely provisional and is subject to being declared 'Eligible' during verification of their original documents at the time of joining at AIIMS Nagpur. In case a candidate fails to submit any requisite documents related to recruitment process of NORCET-06, his/her candidature will be cancelled for the post forthwith. Further, if at any stage it is found that the selected candidate does not fulfill any of the eligibility criteria or if he/she concealed or given incorrect information which if known earlier, would have

rendered him/her ineligible for selection, his/her selection/appointment to the post will be cancelled forthwith at any stage without assigning any reason.
