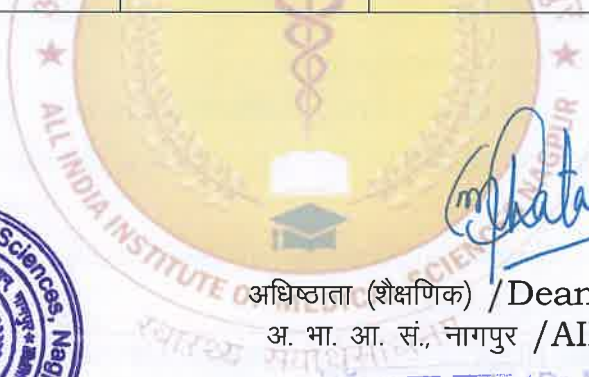
**Instructions for reporting of Postgraduates (MD/MS/MDS)**  
**Candidates (January 2025 session) – 2<sup>nd</sup> Round**

1. All students should get **DD of Rs. 3027/-** (Three thousand twenty-seven rupees only) in the name of **“Director AIIMS Nagpur”** payable at Nagpur at the time of reporting.
2. Original documents along with one set of self-attested photocopies to be submitted while reporting are as follows:
  - I. Offer letter
  - II. Allocation letter
  - III. Registration slip
  - IV. Admit card issued by AIIMS
  - V. Mark sheets of MBBS/BDS 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Professional Examinations.
  - VI. MBBS/BDS Degree certificate
  - VII. Internship Completion Certificate/Certificate from the Head of Institute or College that the candidate will be completing the internship by **31<sup>st</sup> January 2025**.
  - VIII. Permanent/Provisional Registration Certificate issued by MCI or DCI/State Medical or Dental Council.
  - IX. High School/Higher Secondary Certificate/Birth Certificate in proof of date of birth. (Matriculation)
  - X. The Candidate should also bring the following certificate, if applicable:
    - a) SC/ST Certificate issued by the competent authority and should be in English or Hindi in language. Community should be clearly mentioned in the certificate.
    - b) OBC/EWS Original Certificate issued by the competent authority for central Govt. jobs/for admission in Central Govt. College/Institute. The sub-casts should tally with the Central List of OBC/EWS. OBC/EWS Candidates should not belong to Creamy Layer. OBC/EWS certificate must be in the Central Govt. Format as prescribed in the prospectus. The validity of OBC/EWS Certified shall be as follows: -

- (i) The OBC (NCL) certificates issued in the respective financial year i.e. issued from **01.04.2024 to 26.11.2024** (on or before date of exam) both dates inclusive, will be considered valid.
- (ii) The EWS certificate must be valid for financial year **2024-2025** and issued between **01.04.2024 to 26.11.2024** (on or before date of exam), both dates inclusive based on income of year **2023-2024**.
- c) Physical Disability Certificate issued from a duly constituted and authorized Medical Board as mentioned in the prospectus.
