ELIGIBILITY STATUS OF CANDIDATES AFTER COMPLETION OF DOCUMENT VERIFICATION FOR VARIOUS NON-FACULTY POST SELECTED THROUGH CRE-2025 AT AIIMS NAGPUR

In reference to Notice No.278/2025 dated: 11/07/2025 of CRE AIIMS New Delhi regarding recruitment of various non-faculty post on Direct Recruitment Basis on behalf of AIIMS Nagpur and in this connection, AIIMS Nagpur issued Notice No: AIIMS-NGP/CRE-AIIMS/2025/3/DV/3270 dated 04.12.2025 and Notice No: AIIMS-NGP/ CRE-AIIMS /2025/3/DV/3321 dated 05.12.2025, regarding verification of eligibility criteria & Original document of CRE-2025 for provisionally selected candidates for various non-faculty post on direct recruitment basis at AIIMS Nagpur. All the allotted candidates for AIIMS, Nagpur were called for document verification at AIIMS Nagpur 13.12.2025 & 15.12.2025.

2. On the basis of documents submitted by the candidates in support of their eligibility and after examination of the documents, eligibility status of candidates has been prepared and placed as **ANNEXURE-A**.

3. All the 'Provisionally eligible' candidates are mandatorily required to submit documents as mentioned against their name in support of their eligibility by email to nonfac.recruitment@aiimsnagpur.edu.in or through by post/by hand upto **31.12.2025** till **5.30 P.M.** They should email all these documents in a single (merged) pdf file.

4. In case no representation is received from 'provisionally eligible' candidates within the specified date (**31.12.2025**) then it will be considered as the concerned candidate is not having any documents/claim in support of his/her eligibility. Such candidates shall be declared 'Not Eligible' for CRE-2025 without giving any further notice.

5. Representation received after **31.12.2025**, through email or any other mode from any of the candidates will not be considered under any circumstances.

6. Offer of appointment to all 'Eligible' candidates, mentioned in the ANNEXURE-A of this notice will be issued shortly.

7. Candidates must note that their candidature is purely provisional and is subject to being declared 'Eligible' during verification of their original documents at the time of joining at AIIMS Nagpur. In case a candidate fails to submit any requisite documents related to recruitment process of CRE-2025, his/her candidature will be cancelled for the post forthwith. Further, if at any stage it is found that the selected candidate does not fulfil any of the eligibility criteria or if he/she concealed or given incorrect information which if known earlier, would have

rendered him/her ineligible for selection, his/her selection/appointment to the post will be cancelled forthwith at any stage without assigning any reason.
