Terms and Condition

1. **Temporary Basis:** The mentioned posts are on a temporary basis.
2. Since the posts are temporary, incumbents selected will have no claim for regular appointment at **AIIMS Nagpur** or ICMR or continuation of their services in any other project.
3. The persons engaged on Project Human Resource Positions shall not have any claim on a regular post in ICMR or in any of its Institutes/Centres or in any Department of Government of India and their project term with breaks or without breaks in any or multiple projects will not confer any right for further assignment or transfer to any other project or appointment / absorption / regularization of service in funding agency or in ICMR. Benefits of Provident Fund, Pension Scheme, Leave Travel Concession, Medical Claim, Staff Quarters and other facilities applicable to the regular staff of ICMR etc. are **not admissible** to the project human resource positions.
4. **Selection Authority:** The Director & Appointing Authority has the right to accept or reject any application without assigning any specific reason. Correspondence regarding this matter will not be entertained.
5. **Original Documents:** Candidates should submit all certificates/testimonials in original form for verification at the time of the written test/interview.
6. **Application Submission** Applicants must bring a one recent photograph, one set of photocopies of qualifications, experience, and other certificates and testimonials.
7. **Interview Requirement:** Failure to bring original certificates to the written test/interview will result in disqualification from consideration.
8. **Experience Certificate:** It should clearly state the nature of work during the period of employment. Experience should have been gained after acquiring the minimum essential qualification.
9. Persons already in regular time scale service under any Government Department/Organizations are not eligible to apply.
10. **No-Objection Certificate:** Required from the current employer for Govt. Servants only.
11. **For Reserved category Certificate:** Candidates must produce their latest Caste Validity Certificate. OBC candidates must possess a latest valid non-creamy layer certificate valid OBC-Non-Creamy Layer certificate in Government of India format for current financial year. PWD candidates shall produce latest disability certificate issued by a medical board of Government hospital with not less than 40% disability.
12. **Age Relaxation:** Age relaxation is applicable for certain categories (e.g., SC/ST, OBC) as per government rules issued from time to time. Upper age limit is Relaxable to 5 yrs. for SC/ST candidates and 3 yrs. for OBC candidates. Age relaxation of 2 years may be given if the candidate has adequate field experience.
13. **Eligibility Criteria:** Age, qualifications, etc., will be considered as of the last date of receipt of applications. Mere fulfilling the essential qualification does not guarantee the selection.
14. Eligible candidates will be shortlisted on basis of **desirable criteria** and will be invited for interview.
15. **Results Announcement:** The results of the final selection will be posted on the AIIMS Website.
16. Canvassing in any form will be a disqualification.
17. Submission of wrong or false information during the process of selection shall disqualify the candidature at any stage.
18. The Institute may conduct written / skill test if required.
19. No TA/DA will be paid to attend interview/personal discussion and candidates have to arrange transport/accommodation themselves.
20. **Document Verification:** At the time of joining duty, candidates should bring all original certificates of educational qualifications, Adhar card, Objection Certificate (NOC) from the present employer, experience certificates, and two passport photos, other relevant certificate (if applicable) along with one set of xerox.
21. The recruited project staff is eligible for leave as per project recruitment rules and will have to give undertaking before joining.
22. The appointee may be relieved from the current job position, with one-month prior notice, failing to do so may be held responsible for paying one-month salary.
23. In case of any unforeseen circumstances, if the project is stalled or postponed, the salary may be delayed/ stopped for that period.
24. If the project/ programme is not extended; the contract will be terminated without any notice and
